



“SPRING INTO SUMMER HAPPI HOME UPDATE”

OFFICIAL RULES

April 23rd – June 5th 2021

Promotion begins on Friday, April 23rd, 2021 at 12 midnight and ends when a winner is determined on June 5th, 2021.

1. Entrants will complete an entry form, including a short written 92-word explanation of how winning would make them HAPPI. Entrants will submit this form via our website www.happi927.com, via traditional mail or written entry to our business office at 1229 State Street, Erie, PA 16501. **Any entry greater than 92 words in length will be disqualified.**
2. The Programming Department at HAPPI 927 will accumulate a list of submitted entries and begin announcing listeners' names on the air on the week of April 26th, 2021. Listeners' names will be called at the time of day they indicated they listen to HAPPI 927. The entries will be chosen based on legitimacy, sincerity, and intent. HAPPI 927 will continue calling out entry names until either 92 entrants are qualified, or until Friday, June 4th, 2021.

All entries must be received by 12 noon on June 4th, 2021!

3. Entrants must be 18 years or older, must be a homeowner OR residing in a home owned by a family member, living in the HAPPI 927 terrestrial listening area, and meet any and all other criteria established within these rules. Contest does not apply to those renting homes.

4. LIMIT ONE QUALIFYING ENTRY PER HOUSEHOLD.

5. When a listener's name is announced on air, that person has 9 minutes and 27 seconds to call the studio request line, 814-454-0927, to be named a QUALIFIER. Qualifiers' names and 92-word entry may be read on-air.

6. Each qualifier will be instructed to appear physically at the UHAUL location off upper Peach Street (2255 Downs Drive) to have their identity verified. Qualifiers will review the Official Rules for contest. Each qualifier will be required to sign a release form at this time. Qualifiers must complete all paperwork by 11am, Saturday, June 5th, 2021, to participate in the promotion or face disqualification.

7. Each qualifier will be invited to participate in a key opening ceremony at U-HAUL (2255 Downs Drive) on Saturday, June 5th, 2021. Registration will begin at 10:00 AM. Each qualifier MUST appear in person in in order to have their name officially entered into the prize cage. Qualifiers who are not formally registered by 10:45 AM are disqualified and forfeit their opportunity to participate as wellas any claim to win.
